Alderman Higdon stated the difference is the interim put behind their name. These people are instrumental to the City. You can still do what you need to do, still work with them. If you don't like them you can write them up and bring your recommendation to the Board.

Mayor Ferguson stated I just want to get to know them, to see who I want to put in their position. Kenny, you said no Cities have done hold overs.

Kenny Stockton answered that he did not say that. I said every City was doing appointments today.

Mayor Ferguson stated that since we are appointing them, I can't do anything.

Kenny Stockton stated, with all due respect, a Mayor cannot hire or fire anyone. Everyone is still hired at the will and pleasure of the Board. Their employment/appointment is not a contract.

Mayor Ferguson stated he just wants the public to know that we are going based off of the old Mayor's agenda and a 2008 opinion.

Alderman McLendon asked Kenny if there is an AG opinion or any statue that states a non-appointed person would be more of a liability to the City than an appointed person.

Kenny Stockton stated the Attorney General's office does not issue opinions as to liability and I'm not aware of a case that has addressed this issue on point. Of course I will be happy to do further research if requested.

Olive Branch's mayor made appointments, but he already knew the people there. Mr. Latimer just wanted to get to know people first, that is what Tom is trying to do, it's nothing personal.

Alderwoman Brooks stated it's almost like a probation period.

Mayor Ferguson stated yes, you saw Mr. Stockton's letter. Mine was shot down. There's no sense in continuing with this, there's now going back to my agenda. I just wanted the public to know what I was trying to do. These are the ex Mayors appointments, approved by this Board. Let's just move on. I just wanted the public to know what I was trying to do.

Mr. McLendon asked Chief Jones if he was going to be looking for a new job tomorrow.

Fire Chief Jones answered no sir.

Alderman McLendon asked why Chief Jones was not on the list.

Kenny Stockton stated that the Fire Chief's position is not statutorily appointed.

Alderman McLendon asked so statutory strictly has to do with law.

Kenny Stockton answered it is for City Clerks, Deputy Clerks, etc. I know a lot of people think that position is appointed, but it is not. A Fire Marshal is appointed, but we don't have that.

Alderman Hobbs stated that there is a motion on the table.

Mayor Ferguson asked if anyone else would like to speak on the matter.

Robin Cotten, 719 Rowen Oak Place, stated that he doesn't know why you won't give the new Mayor a chance. We trust his judgement for the City of Hernando. He's not going to run anyone off unless they mess up.

Simone Johnson, 450 Losher Street, stated that she was disappointed that the Board doesn't support Mayor Ferguson.

Alderman Higdon stated that's not what it is at all. We have to continue to have Court and keep the public safe. If you come to work with interim by your name, and you have a family to support, you come to work every morning not knowing if that's your last day. You're going to start looking for a job and we can't lose some of these professionals until we have someone that can replace them. Ferguson can review every employee he has any time he wants. He can bring it back to this Board and this Board can act on it. If it's just cause, the Board will act on it. You can't expect a person to come to work 180 days with interim by their name.

Mayor Ferguson stated that he didn't ask for 180 days, it's up to 180 days. Mr. Ferguson asked Kenny if he could comment on that, so the judge on holdover cannot hold court?

Alderman Higdon stated that they can hold court, I'm talking about if he left we couldn't hold court. If we lose 3 people this week, how are we going to hold court.

Mayor Ferguson stated so the reason is you think everyone is going to quit if we do the hold over.

Alderman Higdon answered that he thinks we will lose some people.

Alderman Hobbs stated Mr. Mayor, you have over 50 years of experience with us combined sitting on this Board. Why can't you take our word for it that these people are the ones for the job right now. Why can't you trust us, you want us to trust you. Trust our opinion. We have been here a little bit longer and we have a lot more experience. In 180 days, you're not going to know your own job, much less these professionals out here.

Mayor Ferguson stated right.

Alderman Hobbs asked Mayor Ferguson if he understands what he is saying.

Mayor Ferguson answered no.

Alderman Hobbs stated they are educated in their jobs.

Mayor Ferguson stated right. I don't understand where this is going.

Alderman Hobbs why don't you just take our opinion on it.

Mayor Ferguson stated I just ask for 180 days lay over to evaluate these people. Do you know all of these people, their duties, responsibilities?

Alderman Hobbs answered pretty much.

Mayor Ferguson stated well I want to know that too.

Alderwoman Brooks stated but can't you still do that, you can work with them and you don't agree with them, you still have the ability to replace them. You can bring it to the Board and we can make that adjustment.

Mayor Ferguson stated it's a different form of action.

Alderwoman Brooks stated in one case you have people that are unsure of what they have and the other case they are less unsure. Either way their jobs are kind of iffy. Either they can leave or not leave.

Mayor Ferguson stated we need to move on.

Alderman McLendon asked Police Chief Worsham, during the hold over period in Horn lake, how many people left. How many Department Heads.

Police Chief Worsham answered he didn't know. He didn't get to have than information, he wasn't involved with that.

Alderman McLendon answered none, no one left.
