REQUEST FROM THE FIRST REGIONAL LIBRARY FOR FUNDING FYE 2018

Judy Card with First Regional Library presented the request from the library. Mrs. Card thanked everyone for all that they do for the library. The library is a very busy place and provides many services to our community. Mrs. Card introduced Jesse Pool, the head librarian. Mrs. Card stated that the Library would like to request \$129,118.09 this coming budget year. This increase in the request of \$20,000 will help fund what the state has cut out for personnel and it would help with a new phone system.

Alderman Harris suggested maybe the City and Library could combine phone systems.

Alderman Hobbs asked if that was legal.

Kenny Stockton stated that it may be, he will look into it.

Alderman McLendon asked how much was cut from the state.

Judy Card answered around \$106,000.

Alderman Hobbs asked if the county participates in funding the Library.

Alderman Miller asked what the percentage difference was.

Alderman Higdon stated roughly 17%.

Mayor Ferguson stated that we will take this into consideration during our budget process.

DISCUSSION OF CITY EXPENSES FOR CHARITY 5K AND 10K'S

Alderman McLendon asked what impacts more, the Library or 5K's. Keep that in mind when we talk about 5K's. We have a list of what it costs for our Police when we do a 5K. Alderman McLendon asked Captain Lanphere if the numbers were pretty accurate. Alderman McLendon asked if the costs of Police Officers for the races be added to the record.

The original 5K race route used by the city which begins at Center Street goes down Hwy 51, turns right onto North Parkway, then turns down Mt. Pleasant to Robinson, left on Northview, across Commerce then back down Center Street has 15 spots where officers have to maintain a post. The race usually last an hour and a half to two hours. The estimated cost per race is around \$1663.52.

The alternate route which has been used in the past is the Northview Point route. It begins on Byhalia east to Double Shovel, right on Middle Buster, left on Single Tree, right onto Milam, across Mcingvale into Lakes of Ceder Grove to Bending Oak S, left on Bending Oak E, left on Bending Oak N, onto Green T Drive. They take a right onto Byhalia back to Northview Point. We only have to use 5 officers for this route, with an estimated total of \$562.27 for this route.

Police Captain Charles Lanphere answered yes. Captain Lanphere stated that it would take approximately 15 officers if we use the tradition route, and approximately 5 officers if we used the Longview Point route. The Longview Point route is easier and takes less officers to operate.

Alderwoman Brooks stated that we heard from one resident, I believe in Magnolia Manor, that stated they were trapped, and could not get out during a 5k. Is there any way to prevent that?

Captain Lanphere answered yes ma'am. The tradition route we have to shut down Highway 51 and Mt Pleasant and Grand Manor. With the Longview point we don't' shut down any streets.

Mayor Ferguston stated that we are looking into different routes also.

Alderman Higdon stated that it looks like the one route costs 3 times as much.

Alderman McLendon asked if we have a number of 5ks we have a year.

Mayor Ferguson answered not yet, we are working on it. We really want to stick to the 4 traditional ones. I'm trying to encourage when they have fundraisers they have them at the civic center, football field or some public ground. We appreciate everything they do, but staying off the streets or limiting what we do is what we need to look into doing right now.

Alderman Hobbs asked if tax payers should be absorbing the cost. Should we take the cost out of the money raised by the charity.

Mayor Ferguson stated that he things that is part of our volunteerism We want to limit it to some extent.

Alderman Higdon stated that we need to abandon the route that takes more officers.

Alderman Hobbs stated that soon everyone in the county will have their races here in Hernando.

Alderwoman Brooks stated that at we did discuss limiting the number of races.

Mayor Ferguson stated that the more expensive race might not be as expensive when other things are going along with it, like the A'Fair.

Alderman McLendon asked what impact do they give to the community, Interfaith, Noah's Gift, etc..

Alderman Hobbs asked if we could bring this back with more information on the number of races, the times they start and how many people are affected by the races.

DETERMINE ROUTE FOR THE 5K REQUESTED BY THE INTERFAITH COUNCIL ON POVERTY

Roxanne McIngvale presented the request from the Interfaith Council on Poverty for their 5k. Mrs. McIngvale stated that this race is our only fundraiser for the food pantry. We have 16 churches that help us. Mrs. McIngvale stated that they have used this route since 2005, we didn't ask for this route, it was just given to us. Three of our churches are on this route, so we can use them for water stations. All of our clients are screened and have to live in Hernando or Nesbit.

Alderman Miller stated that we need to keep doing this one. There are actually more churches that help, they just work under some of the ones listed.

Alderman McLendon stated it is not like y'all are taking money and spending it loosely, the expenses are going down.

Mrs. McIngvale answered yes, we spend it very wisely. Every penny from the race goes to the food pantry.

Mayor Ferguson asked if the 8-10am was a good time for their race.

Mrs. McIngvale answered yes. We even draw runners from Memphis to this race. If we didn't have the race I don't think we would be able to have the food pantry.

Key Stewart stated that she worked in the very first food bank, in the metal trailer, the program is worthwhile.

















Alderman McLendon asked if this was going to affect the drainage easement.

Alderman Higdon stated that he has spoken to the Police Department and they have looked into it.

AUTHORIZE MAYOR FERGUSON TO SIGN THE FY2018 DUI ENFORCEMENT GRANT WITH MS OFFICE OF HIGHWAY SAFETY

Kenny Stockton stated that he meet with the Mayor and Captain Lanphere, there is a requirement that the staff has to be new staff. We want to get clarification or a modification that we don't have to hire 2 new officers to receive this grant.

Captain Lanphere stated that he was told you would have to hire new officers if it is sub planning. Since we have been doing this for 4 years, it is just a reimbursement, we are using it for the same officers.

Kenny Stockton stated that he would suggest that it be approved with clarification.

Mayor Ferguson stated that he wants clarification, he doesn't want to miss the money or have our hands tied.

Alderman Higdon stated that under performance, it states increase DUI's from 278 for fiscal year. Is that from 273 to 278 or starting at 0 and going to 278?

Captain Lanphere answered that it was from 0 to 278, in a fiscal year.

Mayor Ferguson asked if we don't meet the numbers, will we lose the money?

Captain Lanphere answered that we could, but in our position, being close to I55, I69 and the casinos, I don't think we will have a problem with the numbers.

Motion was duly made by Alderman Miller and seconded by Alderman Higdon to authorize Mayor Ferguson to sign the FY2018 DUI Enforcement Grant with MS Office of Highway Safety, after receiving clarification of the new officers. A vote was taken with the following results:
