WHEREAS, the Mayor and Board of Aldermen pursuant to the requirements of Section 23-15-857 of the Mississippi Code of 1972, Annotated, as Amended do hereby recognize that a special election be held within the City of Hernando, Mississippi for the purpose of fulfilling the unexpired term of the late Elhannan R. "Sonny" Bryant;

WHEREAS, the Mayor and Board of Alderman of the City of Hernando, Mississippi did meet at a duly noticed special called meeting within the statutory period of time as set forth in Section 23-15-857 of the Mississippi Code of 1972, Annotated, as Amended; and

WHEREAS, the City of Hernando has the authority to take this action pursuant to the authority as set forth in the above referenced state statue.

NOW, THEREFORE, BE IT ORDERED by the Mayor and Board of Aldermen of the City of Hernando, Mississippi as follows, to wit:

A. That a special election be held on the following date:

January 19, 2021.

B. That all posting and notice requirements be made by the municipal clerk as required by Section 23-15-857 of the Mississippi Code of 1972, Annotated, as Amended.

Motion was duly made by Alderman Higdon and seconded by Alderman Harris to adopt the Order as presented in regard to the vacancy created by the departure from this life of the late Sonny Bryant and further move that the special election be held in accordance with the ward boundaries as in place at the time of the election of the late Sonny Bryant in 2017 as Alderman for Ward One (1) for the following reasons: (1) That the special election is for the unexpired term of the late Sonny Bryant. (2) That the recently adopted reapportionment/redistricting plan for the City of Hernando, Mississippi pursuant to the Ordinance as adopted on November 17, 2020 is not yet final in accordance with the laws of the State of Mississippi. (3) That any attempt to hold the special election in accordance with the revised boundaries, as set forth in the November 17, 2020 Ordinance, for Ward One (1) of the City of Hernando, Mississippi would be very unlikely as notice to all those citizens affected by the reapportionment/redistricting ordinance could not be made in time for the special election. This has been confirmed by the City Clerk with the office of the DeSoto County Circuit Clerk as well. (4) That the reapportionment/redistricting ordinance has the net effect of changing the voting wards for the following number of citizens based upon the 2010 census data being the last such census data available and which are as follows: Total Population affected: 2,551 - Voting Age Population affected: 1,764. This information is based upon the changes made to Ward 1, Ward 4 and Ward 6 respectively in the adoption of the aforementioned ordinance. The Ward 1 and Ward 5 changes, according to the 2010 census numbers have been estimated to affect only commercial property at that time so no citizens would be impacted. (5) That any attempt to hold the special called election in accordance with the recently adopted ward boundaries for the City of Hernando would result in unnecessary confusion and would in essence have the net effect of being inequitable to a large number of citizens within the city and especially those in the existing Ward One (1) of the City of Hernando, Mississippi who have since the 2017 municipal election been represented by the late Sonny Bryant. I request that foregoing information be made a part of the record and included within the minutes.
