DISCUSSION OF CARES ACT MONEY

Alderman Miller stated he has received all of the information he needed on the CARES Act money and would like to end this discussion on CARES ACT.

Mr. Miller stated he would like to look at giving employees a 1.5% raise out of the general fund, put on the next agenda.

Alderman McLendon stated that would need to be moved to the next agenda.

Alderman Miller stated right. I was clarifying it, so it wouldn't be political, like some people are trying to do. So you wouldn't take it at say that we are trying to give raises with the CARES Act money.

Alderman McLendon stated thank you so much.

Alderman Hobbs asked how much is 1.5%.

Alderman McLendon stated we are talking about the CARES Act.

Human Resource Manager Julie Harris stated that she gave all of those numbers to the Mayor. I didn't figure a 1.5%, I figured a 1%, 2%, and 3%, but I will be happy to figure a 1.5%.

Alderman Harris asked if we are looking at 9 months or 12 months.

Human Resource Manager Julie Harris stated she calculated both and gave them to Mayor Ferguson.

Alderman Harris stated if we approve a 1.5%, we are looking at 9 months.

Alderman Miller stated he would like to have the 1.5% raise for employees on the next agenda.

Alderman McLendon stated I don't know why we are talking about something that isn't on the agenda.

Human Resource Manager Julie Harris stated that the total for a 1.5% increase would be \$124,269.30 for 9 months.

Alderman Hobbs asked if we can get a 1.5%, 1.75% and a 2% for an 8 month time period before the next meeting, or whatever the time period is left for the fiscal year. We might can give an addition increase since the time is less now.

Alderman Higdon stated he has still yet to see the financial status of the city.

Alderman Hobbs asked where we are with the 2019 audit.

Mayor Ferguson stated where do we stand on that Katie.

City Clerk Katie Harbin stated that we are waiting for Melinda to finish up her work and then the Auditor to finish their part. The last update I was given was it should be completed within the next couple of months.

Alderman Higdon stated so the end of April.

City Clerk Katie Harbin answered yes.

Alderman Hobbs asked without the audits being complete, is that illegal, we can't get a grant without these audits, is that right, we can't apply for them without the audits?

City Clerk Katie Harbin answered that would be correct for most grants I would think.

Alderman Hobbs asked typically when should the audit be done.

City Clerk Katie Harbin answered within six (6) months of the year ending.

Alderman Hobbs asked why are we so late.

City Clerk Katie Harbin answered we got behind years ago when we had to change firms, in 2017, then they just working on them to catch up. We were almost caught up this time last year, they were working on them, but I believe COVID hindered the Auditor with his work and they just fell behind from there.

Alderwoman Brooks asked is there anything we can do.

Alderman Miller stated no, it's just the process. We had some underlying circumstances that couldn't be avoided.

Alderman McLendon stated I have a question concerning the CARES Act money. This money that we spent, that we received, did we have this coming in from the previous year. So if

we spend money, it was left over from last year. Then we got reimbursed. From money that was carried over.

City Attorney Kenny Stockton stated no.

Alderman McLendon stated I'm just wondering.

Mayor Ferguson asked Katie can you answer his question.

City Clerk Katie Harbin asked Aldermen McLendon to repeat the actual question.

Alderman McLendon stated we got CARES Act money.

City Clerk Katie Harbin answered correct.

Alderman McLendon how did they come up with the formula for that. Did we issue a receipt, how did we do that.

City Clerk Katie Harbin the State received money, they divided it up amongst the Cities based on population. We have a set amount that we received. In order to get that I had fill out a form and send in backup that shows where we spent money that was related to COVID and that was Personnel, since that was our largest expense.

Alderman McLendon stated so they reimbursed us money.

City Clerk Katie Harbin answered yes.

Alderman McLendon stated ok so we had money left over last year in abundant, or either we had an abundance of sales tax money, that we used to pay for COVID and then we got paid back from the State

City Clerk Katie Harbin stated I would have to go look to see if we had anything left over from last years budget. We are doing well with Sales Tax, so it's possible it is a combination of both.

Alderman McLendon stated so everyone has a clear picture of how we got the money. Did we have an excess of money going in.

City Clerk Katie Harbin answered we don't have an excess of money going into a budget.

Alderman McLendon stated so from October 1st to now, we've increased #330,000 basically. That's what we are saying we got from the State to go in the general fund for stuff that wasn't budgeted in this year's budget.

City Clerk Katie Harbin answered yes..

Alderman McLendon stated so this is over from what we projected.

City Clerk Katie Harbin answered yes.

Alderman McLendon stated we are \$330,000 over what we were projecting for the 2021 budget, at this time.

City Clerk Katie Harbin answered at this time.

Alderman McLendon stated not all year, but at this time.

City Clerk Katie Harbin answered correct.

Alderman Miller stated and the only reason it is over is because the State sent the money to us.

Alderman McLendon stated by the formula of what you spent.

City Clerk Katie Harbin stated no sir, by the population.

Alderman McLendon stated no ma'am.

City Clerk stated yes sir, that is what they stated.

City Attorney Kenny Stockton stated no we are not.

Alderman Hobbs stated Mike I have a question for you, did this have to go through Legislation.

City Attorney Kenny Stockton stated yes it did.

Alderman McLendon stated it did.

Alderman Hobbs stated quit wasting our time. If we are doing something wrong, let us know. Quit asking question that you already know the answer to.

Alderman McLendon stated each meeting I've said it's illegal.

City Clerk Katie Harbin stated Alderman McLendon I've asked for that information, I've researched it, I've called different State agencies, and no one knows what you are talking about.

City Attorney Kenny Stockton stated we haven't done anything illegal. Alderman McLendon stated at the last meeting we have, he said he'd send us the documentation. I never received anything. I asked Katie and the Mayor, if they had gotten anything, they haven't received anything. I'm assuming no one else on this Board has received anything. I immediately researched it after the meeting the other night. MML has published nothing regarding what Alderman McLendon is talking about. I also called the State Auditor and we did it exactly the way we were supposed to. It was very simple, a very simple formula. I was amazed at how simple it was. It was based upon population. All you had to do is say that you spent X number of dollars, which Hernando, Olive Branch, Southaven, and all of the other Cities have been more than able to do. So, Alderman McLendon if you have any knowledge that the City of Hernando has broken any law, any law, relative to the CARES Act you're under a duty to not only share that information, but to provide that information.

Alderman McLendon stated that MEMA has that information.

City Attorney Kenny Stockton stated Alderman McLendon you stated last time you had information and what we were doing was illegal. To this day, I haven't received that. I have researched it. You tell who to call, that Hernando, and I guess every other City in this State is violating the law.

Alderman McLendon stated nobody used it for raises.

Alderwoman Brooks stated we aren't doing that.

City Attorney Kenny Stockton stated that has nothing to do with this.

Alderman McLendon stated we discussed raises under the CARES Act.

City Attorney Kenny Stockton stated but if you wanted to do that, it is perfectly legal too.

Alderman Harris stated the motion that has been made isn't to use CARES Act money, the motion before us is to use general fund money.

City Attorney Kenny Stockton stated that was not in the form of a motion, that was just discussion.

Alderman Harris stated that item is for the next agenda, we aren't using the CARES money for pay raises.

Alderman McLendon stated that is all I needed.
