

## VII. POSTING OF ZONING HEARINGS

---

City of Hernando requires site posting for all rezoning cases. Site posting instructions are as follows:

1. The sign must be posted fifteen (15) days prior to date of the first public hearing. It shall be the responsibility of the applicant to maintain the sign until the Board of Alderman renders final decision.
2. Applicants may use the sign vendor of their choice.
3. Sign shall be 4'x8' minimum size.
4. It shall be constructed of laminated plywood or similar material.
5. The front, back, and all edges shall be painted with RED acrylic exterior enamel.
6. White lettering shall be used.
7. Signs must be removed from property within 30 days of the Board of Alderman decision.

It shall be the responsibility of the applicant to erect and maintain the notice on the subject property until final disposition of the case and to remove the sign within one week of the final public hearing. The Planning Director shall determine the number of notices and locations required.
