DISCUSS FY24 BUDGET

Alderman Miller stated he is looking for a \$1M contingency. He wants a 4% employee salary increase across the board. PERS is a benefit that potential employees do not consider. The difference between a 5% and 4% raise is \$108,078.00 in the General Fund and \$13,564.00 in the Utility Fund. The 1% savings could go into contingency. Last year the Fire Department received an excessive raise. Public Works and Parks did not get a bump like that.

Alderman Wicker agrees with a 4% salary increase across the board. He asked if the \$30,000.00 Election budget was for a future Special Election.

Alderwoman Ross stated the city must be competitive. Some employees went from \$8, \$10, and \$12 last budget. We must invest in certain areas to recruit employees. Department heads can come back in mid budget season and ask for more staff dollars.

Lee Germany stated DCRUA is going to go up significantly. Rainwater in the drainage system will be looked into to see if we can get that stopped. Garbage rates will go up from \$17.50 to \$22.00 and only have \$200K in contingency. Hope to get DCRUA under control so we do not have to raise rates on the citizens.

Alderman Harris agrees with the 4% salary increase with unknown expenses to absorb such as DCRUA. 2017 was the last garbage rate increase.

Mayor Johnson has heard the 4% salary increase from the Board. He wants a 5% increase since we went backwards last year which mounts up over time.

Alderman Wicker stated if we can find \$121,000.00, we can look at it. We will get direction from PERS and not push it forward, then come back to look at adding to salaries. Possibly come back in 90 days and ask for another 1%.

Lee Germany stated he cannot operate with a \$200,000.00 contingency fearing a water plant goes down for instance. Alderman Miller agreed that they all have that fear. Lee Germany stated he has no solution. Alderman Miller suggested they look a Public Works throughout the year and see how we are.

Mayor Johnson stated a \$327,000.00 bond note drops off this year, and a CAP loan is to drop off with money for the sale of land.
