Cemetery Perpetual Fund – We created a new separate fund for the Cemetery Perpetual Fund.

Parks Fund - We had to increase revenues and expenses due to more participants playing in baseball and soccer. We also had to increase adult basketball expenses due to the school gym rental fee and more referees.

Utility Fund - We increased and decreased some expenses to budget for repairs to equipment, vehicles and personnel expenses.
