INTRODUCTION:

It has come to the Planning Commission's attention that the Zoning Ordinance does not address the use of fencing material that is used around residential tennis courts. Thus, the Commission is bringing forth an amendment to Article XII, Section (a), Paragraph (i)(4) for the Mayor and Board to consider.

CURRENT ORDINANCE:

Article XII, Paragraph (a), Section (i)(4) states the following:

Tennis courts, swimming pools, garden houses, pergolas, ornamental gates, barbecue ovens, fireplaces, and similar uses customarily accessory to residential uses.

PROPOSED ORDINANCE AMENDMENT:

Article XII, Paragraph (a), Section (i)(4) states the following:

Tennis courts with associated earth toned, vinyl covered chain-link fencing, swimming pools, garden houses, pergolas, ornamental gates, barbecue ovens, fireplaces, and similar uses customarily accessory to residential uses.

PLANNING COMMISSION COMMENTS:

Tennis courts often employ chain-link fencing around the court to assist in retaining loose tennis balls and to further define the playing area. Other fencing materials can be used for the same purpose that meets the fencing standards for residential zoning; however, the approved materials such as masonry or wood boards do not have the necessary elasticity to absorb impacts and could be considered a safety hazard. Therefore, the Commission recommends the use of vinyl covered chain-link fencing for tennis courts associated with residential accessory uses.
