## AUTHORIZE THE MAYOR TO SIGN A CHANGE ORDER FOR THE LAGOON RECLAMATION PROJECT

After review of the lagoon reclamation project in detail with the project engineer, Tiffany Heard and the proof offered in support of certain change orders by said engineer, the following findings are hereby made and offered in support of a Motion to allow the Mayor to make the necessary change orders to the existing construction contract with Trey Construction, Inc. The change orders and the information and findings associated with the same are as follows:

- A. To include a section of "RCP" pipe for the purpose of replacing the existing "ditch" pipe, which was found by the project engineer to have at some point prior to construction to have "collapsed" and which is not functioning properly. That the pipe is essential to the project and is necessary to continue to move the project forward. That the collapsed pipe was discovered during project construction and it is necessary to the project that the same be replaced. The cost of the pipe is estimated to be \$8,750.00.
- B. To include the removal of a large pile of debris the size of which was unknown by the project engineer as the debris pile was located in a wooded area of the site and somewhat hidden. That the pile contains a mixture of debris that must be hauled away from the site and it is necessary to the project that the same be removed immediately. That the project engineer has discussed the matter with the contractor and has been able to secure a reduced rate in the hauling away of the debris by way of "back hauling". The cost of said change order is estimated to be \$6,900.00.
- C. That an extension of the contract completion date has become necessary due to site conditions, including weather delays and the additional sludge quantities found at the site and the project engineer has explained the need for such additional time to

- complete the project. That incidental to the project is the need for the continued presence of an onsite project supervisor as required in the contract and the cost of keeping a supervisor on the site. That it is necessary that the change in the cost of professional services be increased by the sum of \$10,000.00 to cover such cost.
- D. That the project engineer, explained that due to the delay in completion of the contract that any attempt to seed the site for the soccer fields will not be successful as the growing season will have passed. The need for the grass is crucial to the project completion and the recommendation by the project engineer was to return to the "sodding" of the fields as originally set out in the project and which had been previously removed by a prior change order. That it is necessary for project completion that the fields be covered with grass and based upon the information provided by the project engineer the reinstatement of the sod provision of the contract should be made to allow for the completion of the project. The cost of the sod is estimated to be \$40.000.00.

Motion was duly made by Alderman Hobbs, seconded by Alderman McLendon to authorize the Mayor to sign a change order for the Lagoon Reclamation project based on the findings listed. A roll call vote was taken with the following results:

Those voting "Aye": Alderman Hobbs, Alderman Lauderdale, Alderman Bryant, Alderman Miller, Alderman Higdon, Alderman McLendon, and Alderwoman Brooks.

Those voting "Nay": None.
