Joe Frank Lauderdale spoke about the information on the best bids that we received. Joe Frank Lauderdale recommends using North Mississippi Driveways for the Paving, at a price of \$36,461.40 and Magnolia State Products for the surfacing at a price of \$98,534.00.

Poly product 5 year warranty

The latex bid would have cost more in the end because the paving specs they need, were not the same specs given out in the bid requirements.

Alderman Higdon – "How is that poly material applied?"

Joe Frank Lauderdale – "It is applied with a machine. They spray a product on the track first, on the asphalt."

Alderman Higdon - "They seal that really good don't they?"

Joe Frank Lauderdale – "Yes, it is sealed good."

Alderman Higdon – "The reason I ask is that in my previous job we put poly on all of our floors, but we trialed it all to thickness of about ½ an inch."

Joe Frank Lauderdale – "That's what they are going to do."

Alderman Higdon – "It's easiest to maintain a ½ an inch."

Mayor Johnson – "What we are hoping for is a product that we put down that none of us will have to mess with again."

Alderman Miller – "What is the life expectancy difference between the two different products?"

Joe Frank Lauderdale – "What they are saying is the more you use it the more it wears."

Dewayne Williams – "The Poly product you will 15-16 years out of and the latex you will get 11-13 years out of. There all a lot of variables that the life expectancy will depend on."

Alderman Miller – "There is about a 3 year difference."

Mayor Johnson – "So about a 25% difference."

Alderman Miller – "So we are recommending that if we spend \$20K more we can have 3 years more of life expectancy out of that trail."

Joe Frank Lauderdale – "At least that"

Alderman Lauderdale – "Did you say the warranty was longer?"

Joe Frank Lauderdale – "The warranty is longer to start with, plus there must be a reason that everybody went from latex to the poly product. That seems to be the more acceptable one."

Alderman Miller – "It's going to be a life expectancy of 3 years longer for an extra \$20K, and that's the best bang for the dollar."

Alderman Lauderdale – "Plus warranty."

Alderman Miller – "The warranty is just the five years."

Alderman Lauderdale – "You could still have a problem in the first five years."

Alderman Higdon – "How much did we receive to complete this?"

Mayor Johnson – "160K, but there are some bathroom renovations that will be done with the other money, that are a part of this project."

Motion was duly made by Alderman Manning, and seconded by Alderman Bryant to accept the best bids from North Mississippi Driveways with a bid of \$36,461.40 for paving and the bid from Magnolia State Products with a bid of \$98,534.00 for the poly plus product, for surfacing, based on the extra life expectancy of that material.
