Jared Darby answered that these were used under the office designation, which is allowed in most zones except M1 and M2. With the bail bonds agency moving to the M1 area around the new jail, any new bail bond agency located next to shops, commercial centers, our square was thought to need a more conditional review by the Planning Commission.

AUTHORIZE TO ACCEPT THE LOWEST AND BEST BID FOR THE KNUCKLEBOOM TRASH LOADER AND DUMP BED

Bobby Burton presented the following explanation sheet as to why River City had the best bid for the Knuckleboom Trash Loader and Dump Bed needed by the City of Hernando.

Knuckleboom Trash Loader and Dump Bed

6.01 "Trash bucket actuated by a single double-acting cylinder" – This single dual action cylinder is more durable and holds a load better than a grapple with two cylinders that work using a "bite force action". Approximately one month after purchasing a loader with two cylinders that works with a "bite force", a log that was being picked up slipped out and caved in the driver side cab post of truck # 415. What if an employee had been standing there? (picture)

<u>6.03 "No hydraulic hoses below bucket rotator will be allowed"</u> – When you have hydraulic hoses below the bucket rotator they <u>will</u> get hit, pulled on, and pinched by the guards when they become bent. This is an ongoing expense with the brush trucks we now have. By not having any hoses in this area you eliminate the risk of hoses being damaged.

21.01 "Hoist to be "scissor type" dual cylinder with 16 ton capacity" – The "scissor type" hoist lets you power up and also power down. Telescopic hoist power up to dump load and then the weight of the bed pushes them back down. Both trucks the City currently owns have telescopic hoist. They both get hung up at the dump unable to pull forward because the tires are spinning and unable to get the bed down because of load at the bottom. In order to get the bed down employees used the grapple and pushed down on the bed. Over time the front of the bed is bent, bowed, and weakened. This is the reason we need the "scissor type" hoist. (picture)

<u>"Shop within 25 miles"</u> – This allows us to get the truck to the shop for repairs in a more timely matter. Down time can be costly.

Exceptions to chassis bid spec's -

Pac Mac - Bidding a 2014 year model 4x2 Freightliner M2 medium duty 33,000 # GVWR chassis. All 2012 and 2013 build slots are full. Delivery to the body company will be in early March 2013. Then another 40 days to put bed on the chassis.

River City – Delivery date is immediately. The Truck is in Memphis and ready for delivery.

We have had both a Pac Mac and a Peterson truck. This is why we have the knowledge about both types of trucks and how we have determined what works best for the City of Hernando

The price for renting would be \$2,200.00 a week or \$6,000.00 a month

Michael's Tree and Loader Service charges \$350 per load to come pick up

WHEREAS, The Mayor and Board of Alderman resolve to borrow an amount of money not to exceed the sum of eight hundred thousand and no/100 dollars (\$800,000.00) which is less than the fifty percent (50%) maximum amount allowed pursuant to section 21-33-325 of the Mississippi Code of 1972, Annotated, as Amended; and

WHEREAS, The Mayor and Board of Alderman, resolve to repay such money on or before March 15, 2013 as prescribed by the aforementioned statutory authority.

THEREFORE BE IT RESOLVED BY THE MAYOR AND BOARD OF ALDERMAN OF THE CITY OF HERNANDO, MISSISSIPPI AS FOLLOWS:

1. That the City of Hernando, Mississippi shall borrow the sum of eight hundred thousand and no/100 dollars (\$ 80000.00) from FIRST TENNESSEE BANK for the purpose of paying the current expenses of the City of Hernando. That said loan is made in anticipation of ad valorem taxes to be collected for the current fiscal year. The money borrowed from First Tennessee Bank shall bear interest at the rate of .98% per annum and shall be paid in full on or before March 15, 2013. That said repayment shall be paid from the first of moneys collected by virtue of the tax levy and the anticipation of which the money is being borrowed. That said funds being borrowed shall be used for no other purpose than the payment of the current expenses of the City of Hernando and which is authorized by Section 21-33-325 of the Mississippi Code of 1972 Annotated, as amended.

- 2. That the money being borrowed by the City of Hernando, Mississippi from First Tennessee Bank does not violate the interest rate cap as found in Section 75-17-105 of the Mississippi Code of 1972, Annotated, as Amended.
- 3. That the money borrowed, as set forth in paragraph number one (1) above shall be evidenced by a negotiable promissory Note of the City of Hernando, Mississippi in accordance with the following provisions and conditions:
 - A. The money borrowed, shall be payable, principal and all accrued interest to First Tennessee Bank on or before March 15, 2013, in lawful money.
 - B. That said repayment shall be payable without penalty on or before the maturity date.
 - C. That the Note shall be executed by the Mayor of the City of Hernando who shall personally affix his signature to the same and witnessed by the City Clerk of the City of Hernando, Mississippi, under the official seal of the City of Hernando, Mississippi in substantially the form on the attached Exhibit "A", being the proposed Tax Anticipation Note.
 - D. That said Note shall be issued in all respects and in conformity with the law, and the full faith, credit and resources of the City of Hernando, Mississippi, the same being irrevocably pledged to the payment of principal of eight hundred thousand and no/100 dollars (\$800,000.00), and the interest on, said Note as the same matures and becomes due, with said funds to be repaid out of the first money collected by virtue of the tax levy, the anticipation of which such money is to be borrowed.
 - E. The amount of the Note does not exceed 50% of the anticipated, but uncollected, revenue to be produced by the current tax levy of the City of Hernando against which such money is borrowed.
 - F. The Note is hereby designated as a Qualified Tax Exempt Obligation, within the meaning and for the purposes as set forth in Section 265(b) of the Internal

Revenue Code of 1986, as amended.

- G. That said money borrowed by the City of Hernando pursuant to this resolution shall not be applicable to any statutory limitation on indebtedness by a municipality as set forth in Section 21-33-325 of the Mississippi Code of 1972, Annotated, as Amended.
- H. That when said Note shall have been executed by the Mayor of the City of Hernando as provided, the Clerk of the City shall deliver said Note to First Tennessee Bank at its office in Hernando, Mississippi. That the City upon receipt of any note proceeds shall immediately deposit the same in the lawful depository bank for the City of Hernando and shall be placed in the "General Fund" account to be used for the purposes of paying the current expenses of the City of Hernando and for no other such purpose.
