## REQUEST FROM ASHLAND OIL FOR AD VALOREM TAX EXEMPTION

Chris McGee, General Manager of Ashland Oil was present and gave some information about Ashland Oil and their improvements.

#### **GRANTING EXEMPTION FROM AD VALOREM TAXES**

The Mayor and Board of Aldermen took up for consideration the matter of granting tax exemption from ad valorem taxes for ASHLAND INC., the following Resolution having first been reduced to writing, was introduced:

RESOLUTION OF THE MAYOR AND BOARD OF ALDERMEN FO THE CITY OF HERNANDO, MISSISSIPPI, GRANTING TAX EXEMPTION FROM AD VALOREM TAXES FOR A PERIOD OF FIVE (5) YEARS FOR PERSONAL PROPERTY TO ASHLAND INC., AS AUTHORIZED BY SECTION 27-31-101 ET SEQ., OF THE MISSISSIPPI CODE OF 1972, AS AMENDED.

WHEREAS, ASHLAND INC., filed in triplicate with this Board its Application for exemption from ad valorem taxation; and

WHEREAS, ASHLAND INC., has produced written verification and documentation to this Board as to the authenticity and correctness of its Application in regard to the true value of the prayed for exemption and the completion date of said enterprise: and

WHEREAS, this Board finds as a fact that the property described in the aforesaid Application constitutes an industrial enterprise of public utility which was completed on the 31st day of December, 2010, and that said Company is entitled to the exemption sought for a period of five (5) years for personal property beginning on the 1st day of January, 2011, subject to approval and certification by the Mississippi State Tax Commission.

NOW, THEREFORE, BE IT RESOLVED BY The Mayor and Board of Aldermen of the City of Hernando, DeSoto County, Mississippi, as follows:

- 1. That the Application for ad valorem tax exemption by ASHLAND INC., for five (5) years for personal property beginning January 1, 2011 on the property described in the Application filed by said Company for tax exemption, be and the same is hereby approved, five (5) years for personal property subject to approval and certification by the Mississippi State Tax Commission.
- 2. That ASHLAND INC., is hereby granted tax exemption on ad valorem taxes, except Library Fund, Park Fund, G O Bond Fund, State, School District and Road and Bridge ad valorem taxation, for five (5) years for personal property, beginning January 1, 2011.
- 3. That the Clerk of this Board is hereby directed to spread a copy of this Order on the minutes of this Board; and that said Clerk shall forward the original and three (3) certified copies of the Application and a certified copy of the transcript of this Order approving said Application to the Mississippi State Tax Commission for its approval and certification: and said Clerk shall also forward one certified copy to the Tax Assessor of DeSoto County and obtain the Certificate of said Tax Assessor stating that the personal property as itemized in the Application has been placed on the appropriate tax roll as "Non-Taxable", except for Library Fund, Park Fund, G O Bond Fund, State, School District and Road and Bridge ad valorem taxes, for the duration of the exemption period only and the Position Statement of Tax Assessor.

#### MAIL BOX ISSUE AT 380 WEST CENTER STREET

Alderman Tipton spoke about this issue. He had a call from the resident at 380 West Center Street about vehicles parking on the street in front of their home and blocking the mail box, therefore they were not getting their mail delivered. Alderman Tipton spoke with the Mayor

about this earlier today and he spoke with the Police Chief. The recommendation was that we mark out that curb for 25 feet to make it a no parking area in front of the mail box at that address. Mayor Johnson stated that he confirmed with the postal worker that they will not deliver mail if the mail box is blocked. Alderman Tipton also stated that there has been lost mail in the handling of the mail being taken back and forth from the home to the post office.

Alderman Miller stated that he knew where 380 West Center Street was, and asked if we were going to make every area a no parking zone when a citizen comes in here and states that someone is parking in front of their mail box.

Alderman Tipton answered that we are asking to make it on this half of a block west of the Courthouse because we feel like it is Courthouse generated parking is what's creating this, maybe not one hundred percent of the time, but we think due to court and people looking for places to park is the reason this is happening. And this is in a commercial area.

Kenny Stockton stated that there are days, heavy court days, and cars are parked there, other days they are not. It may be setting a precedent but you don't have to address it every time, only if the Board finds that there is a problem at a particular location.

Mayor Johnson asked Police Chief Mike Riley if we have ever had another complaint that you can remember. Mike Riley stated that there hasn't been.

Alderman Manning asked if we should look at the whole block around the square and any place with a box could be treated the same way and that way we wouldn't have to treat these one at a time.

Kenny Stockton advised that most of the others are businesses and are inside.

Mayor Johnson agreed that most of the rest are businesses and have their boxes on the inside. He thinks that there is only one other resident in that area and they have never complained.

Kenny Stockton asked if there were any other businesses with outside boxes around there.

Alderman Miller stated that all around the block, on the east, west, north and south residents have an outside mail box.

Alderman Tipton stated that another issue that could come into light would be when the fire truck goes up West Center Street when it comes out of the station.

Mayor Johnson stated that the Chief did note that the south side of that block is no parking.

Motion was duly made by Alderman Higdon, and seconded by Alderman Lauderdale to approve to mark out on the street a 25 foot 'No Parking' section on the street in front of 380 West Center Street. A vote was taken with the following results:
