Mayor Ferguson asked the Public if they have any questions.

Carolyn Richards asked if there is still money set aside for the animal shelter.

Mayor Ferguson answered yes, it is in the bond fund.

Alderman Miller stated that he appreciates all of the hard work that went into the budget process.

RESOLUTION SETTING AD VALOREM TAX LEVY FOR THE CITY OF HERNANDO, MISSISSIPPI FOR THE FISCAL YEAR 2018 – 2019

GENERAL FUND – on each dollar (\$1.00) valuation as authorized by Section 27-39-307 of the Mississippi Code of 1972, Annotated, for General Revenue purposes and General Improvements, Thirty Three and 11.54/100 (33.1154) Mills.

MUNICIPAL BOND AND INTEREST FUND – on each dollar (\$1.00) valuation as authorized by Section 21-33-45 of the Mississippi Code, Annotated, Four and 72/100 (4.72) Mills.

LIBRARY FUND – on each dollar (\$1.00) valuation as authorized by Section 39-3-7 of the Mississippi Code of 1972, Annotated, 93/100 (.93) Mills.

CULTURE & RECREATION FUND – on each dollar (\$1.00) valuation as authorized for park improvements and maintenance, Two and 0/100 (2.00) mills.

The total mills for 2018 - 2019 is Forty and 76.54/100 (40.7654) Mills.
